

Audits – Is an audit required?

Audit requirements are usually set by statute (state and/or federal, as applicable). Audit requirements may also be cited in bond covenants, loan agreements, or grant contracts.

If federal funds are provided, a Single Audit may be required in addition to a financial statement audit.
