

James E. Herring, Chairman Amarillo, Texas Appointed February, 2004 Mr. Herring's term expires December 31, 2009.

Mr. Herring is president and CEO of Friona Industries, L.P., in Amarillo, Texas. Friona is the fourth largest cattle feeding operation in the United States with four commercial feedlots in the Texas Panhandle with one-time capacity of 275,000 head. Mr. Herring was formerly president and chairman of the board of Marcom International, Inc., a Dallas, Texas, based conglomerate that included a commodity brokerage company, an agricultural finance company, and subsidiaries with various interests in oil and gas, cattle, and real estate.

Mr. Herring was a founding shareholder of First National Bank of Park Cities in Dallas, Texas, and served as a director from 1985 until 1991. Mr. Herring is past president of Texas Cattle Feeders Association, has served several terms on the executive committee and as a director since 1990. He has also served as a director and member of the executive committee of the National Cattleman's Beef Association. Mr. Herring is past chairman of the Cal Farley's Boys Ranch Foundation Board of Trustees and past chairman of the Amarillo Area Foundation. He is a former director and executive committee member of the Amarillo Chamber of Commerce and past chairman of the Amarillo Chamber of Commerce and past chairman of the Rabobank North American Agribusiness Advisory Board and is currently president-elect of Cattle-Fax Board of Directors. In January 2004, Mr. Herring was appointed to the Texas Water Development Board and, in 2008, was named its Chairman by Governor Rick Perry.

Mr. Herring was awarded the Ladd Hitch Award for innovation and leadership by Beef Today magazine for the year 2000 and was presented the Vision Award for that year by the National Cattleman's Beef Association Foundation.


Mr. Herring holds a Bachelor of Business Administration degree from the University of Texas at Austin and an MBA from the Harvard Business School.

Appointed to the Texas Water Development Board by Governor George W. Bush in January 1998, and reappointed by Governor Rick Perry in January 2004, Mr. Hunt was elected Vice Chairman in March 2002 and re-elected Vice Chairman in February 2005. Mr. Hunt is president, CEO, and director of King Ranch, Inc., a land-based multibusiness resource company. Mr. Hunt serves as director of the Texas and Southwestern Cattle Raisers Association and is a former director of the Arvin-Edison Water Storage District and former president of the Tejon-Castac Water Storage District. He also serves as trustee of Baylor College of Medicine, trustee of the Autry National Center in Los Angeles, and member of the Harvard University Food Policy Committee.

Thomas Weir Labatt III, Member San Antonio, Texas Appointed February, 2002 Mr. Labatt's term expires December 31, 2011.

Appointed to the Texas Water Development Board by Governor Rick Perry in February 2002, and reappointed by Governor Rick Perry in June 2006, Mr. Labatt is the president of Labatt Management Co., LLC, and Bundy Ross Ranch, LLC. He served on the San Antonio City Council from 1986 to 1993. Mr. Labatt was a director of the Edwards Aquifer Authority - District 3 from 1996 until his appointment to the Texas Water Development Board. Mr. Labatt is a former chairman of the board of San Antonio Habitat for Humanity and is a past member of the Texas Statewide Volunteer Firefighter's Retirement Fund board of directors.
